

Minutes Annual Meeting May 4, 2004

Shalimar Homeowner's Annual Meeting was held Tuesday, May 4, 2004 at 7:00 PM.

Jim Vance will continue to mow around the lake at \$80.00. Thanks Jim for keeping the lake area looking so nice.

It was time to elect a 1 year board member. Ed Meshach made a motion to elect Judith Schmitz, seconded by Paul Cork, and motion carried.

Jeanine Perkins will be organizing a neighborhood garage sale. Please let her know if you are interested in participating. She is asking that each participant pay \$1.00 toward the ad.

When the water is down on the lake around July or August, Seth with SPE will bring a track hoe and dig out the dam. At that time, Ron Shy will be taking a look at it and make recommendations on how to fix it. Until then, we won't know the cost. All homeowners will be updated at that time.
